DEAR RYAN:

Here's my response to your most recent email (my responses are yellow and in italics):

I'm still trying to get ahold of you to get Alan update on what has been done to address the issue of Jeremiah's mother who is the stenographer or I should say was the stenographer for most of the past year although the last appearance she was not there.

I have a serious problem with the fact that Jena and Jeremiah introduced the woman [*Barbara Scoville was the most recent court reporter for Chelan County Superior Court, but I don't believe she works there anymore*] as Jeremiah's mother when we got to their residence.

I have numerous emails to prior counsel and so far nobody has formally acknowledged this concern and it is deeply concerning as the woman has responsibility concerning being court records. Could you please update me on the situation and if need be, I can create my own motion to deliver at our next appearance for this issue [*I'm rather confused: what is the nature of this motion? What do you want the court to do about this?*].

As far as tow trucks:

I've put together a number of citations, state and federal, which explicitly mandate tow trucks bear the name of company and home city they belong to [*What does this have to do with the pertinent issues in your case, which is whether or not you threatened to kill 3 people?*]. The red tow trucks bare depicted throughout the evidence is clearly labeled B&T of cashmere Washington state. There was no other tow truck. I have photos and videos of the tow truck driving behind my pickup which was driven by the man in the photo which he indicated was his tow truck, and the same man eventually surrendered interest in my truck full stop [*What does this have to do with the issues in your case, i.e., whether or not you threatened to kill 3 people?*].

Further, I have seen the original unedited evidence videos which very clearly establish the deputy asking for tow or service invoices and being very clearly told three times that there was no bill [*What does a tow or service invoice have to do with whether or not you threatened to kill 3 people?*] There was never a tow he admitted to driving my truck [*They retrieved your truck from way back up in the mountains*]. And there was no service rendered [*Yes, there was—they purchased a new wheel and tire, drove 3+ hours, and retrieved your truck for you—that most certainly constitutes a service*] other than the wheel & tire he delivered which I did not want and he admitted to deputy he removed it [*The tow truck people removed the new wheel / tire after they got your truck back down and you were disputing their bill*]. The deputy was even told very clearly, that they put my original wheel back on and aired it up [*I don't know from where you got that notion, but the tow truck drivers put the new wheel / tire on, and then drove your truck back down; the tow truck drivers said your tires were completely shredded and your spare wheel was totally ruined from driving on it*] to make the truck roadworthy.

The same man then drove my passenger to the park and ride where he left her after ensuring she could operate my vehicle. She drove it to Cle Elum before the tire went flat again, and we had to get AAA to tow it here *[What does this have to do with whether or not you threatened to kill 3 people?]*.

For a dispute of magnitudes erupting into alleged threats as they claim, it's bizarre they would just let the truck go as they did.

I now have confirmation of Jeremiah is operations manager for Rivercom, but still no word on his fire employment *[He is a volunteer firefighter]*. As it was, he impersonated a city firefighter *[Actually, no, he didn't because he is in fact a volunteer firefighter for Wenatchee Valley—not any city]* at the scene and the narrative that an understaffed call center had the ability to spare Jeremiah for some sort of volunteer fire duty, on Fourth of July, is absurd *[I don't understand why that is so absurd]*.

Additionally, the claim that he left his volunteer fire duties to volunteer for whatever our emergency was, even if it were death, is even more unbelievable *[Who said he was doing any firefighting duties at that time? He is a volunteer firefighter—they are normally off-duty unless specifically dispatched to help]*. It might even be illegal or violates department policy *[I would be shocked if Jeremiah voluntarily helping a stranded motorist is illegal or a violation of department policy]*. But that's a lot of hops down the rabbit hole spinning a yarn claiming he is basically derelict of two jobs to come take us to his "personal residence". I can't see why he'd do that when he's on call, Fourth of July *[You don't seem to understand the nature and responsibilities of a volunteer firefighter]*.

I have real problems with Rivercom's denial of Jenna being their employee, also. There are a dozen key indicators that she is either a Rivercom employee and they are lying; or she was accessing Rivercom tech as a nonemployee, and abusing it to harm me and my passenger *[How is this relevant to whether or not you threatened to kill 3 people? Even assuming your allegations are true, I can't fathom how they are relevant—unless your claiming self-defense]*.

Most notably, in one video Jenna is heard quietly bragging to Jeremiah and another about how she "just hung up" on me, and my back is to the camera as I struggle to call state patrol in a desperate attempt to get help after Jenna struck me in the face nearly knocking me out *[I didn't see anywhere on the video where Jenna struck you]*. Jeremiah stood next to her watching while I scrambled backwards to escape a physical attack; the original video also shows Jeremiah sprint after me reaching for his gun *[Where in the videos is this?]*. This is attempted murder *[Sorry, but I don't understand how Jeremiah attempted to murder you]*. Clear and plain, and I've already reported this to federal DoJ and other state officials.

The behavioral analysis clearly indicates I'm not threatening and I'm very carefully attempting to create space and diffuse multiple unwarranted attacks *[Did you watch all 8 videos? I mean, you seemed very irate and hostile and acrimonious the entire time]*.

This case was a political kidnapping and conspiracy to commit murder and there is no way you cannot see the mountain of discrepancies in their case *[To be honest, I can't see the "mountain of discrepancies"]*. The prosecutor has extended to you 2 settlement offers:

- 1. Plead guilty to 3 counts of Felony Harassment (range 4-12 months). Prosecutor would agree to recommend First Time Offender Waiver, which means you'd be sentenced to 0-90 days in jail; and 6-months community custody (probation); or*
- 2. Plead guilty to 2 counts of Felony Harassment (range 3-8 months). Prosecutor would agree to recommend the low end 3-months and 6-months community custody.*
